Dear Friends of Culture Works

What a year it has been for Culture Works! The pages of our fiscal year 2022-2023 report are not just filled with numbers but are brimming with stories of a thriving community bound by a true spirit of creativity, collaboration, innovation, and the profound connections fostered through the arts.

In these extraordinary times, we have been privileged to support individual artists and arts groups across the Dayton Region. They have not only rekindled our appreciation for the arts but have helped reforge human connections. It is a privilege to be their financial champions.

The 2022–2023 Campaign for the Arts kicked off with a splash as community members from across the Dayton Region joined together in song at Sing Out Loud. With in-kind support by Dayton Live and donated services of conductor and arranger Mark Hanson, Sing Out Loud featured a community choir of over 100 voices, a 28-piece

orchestra, and dancers from South Davton Dance Theatre—all performing together on the Victoria Theatre stage! We knew this would be an exciting adventure, but we were not prepared for the deep, meaningful bonds that would be created. Participating individuals represented all ages, professions, and sectors of the Dayton Region, and many of them carried the excitement and collaborative spirit of Sing Out Loud back to their workplaces, conducting successful giving campaigns that engaged even more community members and injected vibrancy into area businesses.

Thanks to the generosity of the individuals, businesses, foundations, and community organizations who supported this year's Campaign, we were able to award \$262,027 in operating support to 10 arts organizations through the Community Arts Grant program. Together, we are nurturing the very vibrancy and connections that define the Dayton Region.

Our Community Arts Grant program remains the beating heart of Culture Works, but our investment in arts and culture does not stop there. Four years ago, we embarked on a partnership with the Montgomery County Arts and Cultural District (MCACD) to administer the Special Projects Grant program. In 2022-2023, this Montgomery Countyfunded program awarded \$256,139 to 27 organizations to empower them to connect community members through arts and culture, Another Montgomery County-funded program that we administer, the Artist Opportunity Grant. awarded a total of \$34.890 to 12 local artists to fuel their creative endeavors and development.

Being acutely aware of the importance of mental health and wellness in a post-pandemic world, we extended our Arts + Wellness collaboration with Montgomery County into 2023 to continue providing arts experiences at local workplaces to fuel employees' well-being. We owe a debt of gratitude to the MCACD, our steadfast partner, for making these programs possible. Montgomery County's investment in the arts reaps dividends that allow all of us to thrive.


Many may not be aware that Culture Works also supports the work of student artists through the Leonard P. Roberts Memorial Scholarship. In the past year, we proudly awarded \$24,000 in college scholarships to 10 exceptional students for the 2023–2024 academic year. These scholarships have the power to transform lives, and we are committed to ensuring access to arts education for all.

Finally, we launched two new programs thanks to the support of the National Endowment for the Arts (NEA). In November 2021, we were honored to be chosen by the NEA to receive a one-time \$500,000 grant through the American Rescue Plan (ARP) Subgranting program. With this funding, we awarded \$436,826 to 21 artists and 24 nonprofit arts organizations across Culture Works' service area to inspire new creations and support day-to-day operations in 2022-2023.

But that's not all. The NEA also awarded us a \$50,000 Our Town grant to embark on a two-year artist development and creative placemaking project that will culminate in a collaborative art installation to enhance the Edgemont Solar Garden.

Our journey this year would not have been possible without our amazing staff, who have worked tirelessly and remain passionate about our mission. Our dedicated Board of Trustees, committed to supporting the arts ecosystem in the Dayton Region equitably, has been instrumental. And, of course, we have you, our donors, to thank. Your unwavering belief in our mission and your financial support have been energizing, to say the very least. You have made the magic happen, and we are eternally grateful for your faith in us.

As Sarah Burford eloquently put it, "The arts strengthen community bonds, create new means of connection and understanding, and offer a continuous, powerful, and resilient source of individual and collective identity."



Thank you for being part of this extraordinary journey with us. Here's to a brighter, more vibrant future, built on the foundation of art, connection, and community.

Community Arts Grants

Culture Works is proud to be the united arts fund for the Dayton Region's vibrant arts and cultural community. Thanks to the commitment and generosity of the thousands of community members, local companies, and foundations who give to our annual Campaign for the Arts, our Community Arts Grant program serves as the largest provider of general operating support to many of the arts organizations that bring creativity, unity, and renown to our community.

General operating support is a flexible form of funding that allows organizations to focus dollars on areas of highest need and greatest impact. To qualify for Community Arts Grants, organizations must demonstrate excellence in three areas: artistic and cultural vibrancy, community impact and engagement, and organizational capacity. An independent panel of knowledgeable community volunteers evaluates applications across these three areas using an established scoring rubric. Their scores are then input into a funding formula—along with the amount raised through the Campaign, the number of applicants, and the size of each applicant organization—to determine grant amounts.

Culture Works wishes to thank the individuals, companies, organizations, and foundations who gave to the 2022–2023 Campaign for the Arts and provided \$262,027 in Community Arts Grant funding to support these organizations' 2023–2024 arts seasons:



Artist Opportunity Grants



The Artist Opportunity Grant program exists to support Montgomery County's artists wherever they are in the lifelong process of making art. Funded by the Montgomery County Arts and Cultural District (MCACD), with support from the Board of County Commissioners, Artist Opportunity Grants provide local artists with funding to create new work and pursue professional development opportunities, such as workshops, mentorships, and residencies where they can learn from other artists and hone their skills.





The MCACD provided \$60,000 for the 2022–2023 grant cycle. An independent panel of artists, arts administrators, and other knowledgeable community volunteers evaluated the artistic merit of each project, the potential impact on the artist's career, the public benefit, and evidence of solid project planning. Based on their recommendations, we awarded \$34,890* to 12 Montgomery County artists to complete projects happening between March 1, 2023 and February 29, 2024.

Special Projects Grants

Research by Americans for the Arts shows that participation in the arts fosters cross-cultural and intergenerational understanding, builds community trust and cohesion, and encourages people to learn and feel good about where they live.* Through the Special Projects Grant program. Culture Works and our friends at the Montgomery County Arts and Cultural District (MCACD)—a special unit of county government-work to ensure that all community members enjoy these benefits of arts participation.





The Special Projects Grant program, which is funded by the MCACD and administered by Culture Works, provides grants of up to \$10,000 to local nonprofits, schools, colleges, municipalities, and government agencies to create arts and cultural experiences that connect and inspire county residents. Since 2020, the program has supported 60 projects, including festivals, exhibitions, concerts, theatrical premieres, artist series, public art works, and more. Together, these projects have provided more than 300,000 arts experiences for community members.

As part of our commitment to building equity in our local arts landscape, in the 2022-2023 grant cycle, Montgomery County and Culture Works worked together to reduce barriers to receiving Special Projects Grant funding and to provide greater support to small and emerging organizations going through the application process. Program changes included:

- Adding a new "Capacity Building" project category to support activities such as strategic planning, staff training, and marketing efforts that help arts and cultural nonprofits more effectively engage the community and fulfill their missions
- Increasing the amount of funding available from \$150,000 to \$250,000
- Removing matching funding requirements for small- to mid-sized nonprofits
- Providing free applicant support offerings such as grant writing workshops, project ideation sessions, and consultations

Independent grant panels of volunteer artists, nonprofit administrators, educators, and other knowledgeable community members evaluated applications and made funding recommendations. Through their efforts and the support of the MCACD, we awarded \$256,139 to these 27 organizations** to complete projects happening between July 1, 2022 and June 30, 2023.

Dayton Region Arts Renewal Grants



The COVID-19 pandemic had a devastating effect on arts and cultural organizations and artists. Without the ability to safely invite community members into their spaces, and

without ticket revenue from performances and exhibitions, many organizations had to close their doors, reduce their staff, and wait, Without opportunities to perform, exhibit, or sell their works at community events, artists faced the sudden loss of their livelihoods. Even once it was possible to begin resuming pre-pandemic activities, organizations and artists had to do so with depleted resources and a lingering guestion: Will audiences return?



To help the nation's arts and cultural sector rebuild and recover, the National Endowment for the Arts (NEA) oversaw the distribution of millions of dollars in relief funds to state and local art agencies across the country. In late 2021, Culture Works was one of only two local art agencies in Ohio, and one of only 66 nationwide, to receive an NEA American Rescue Plan (ARP) Subgranting award. In the 2022-2023 fiscal year, we used this one-time \$500,000 grant-the largest such award made by the NEA-to administer the Dayton Region Arts Renewal Grant program.

In July of 2022, we invited Dayton Region arts and cultural nonprofits to apply for operating support grants of up to \$15,000 to use for staff salaries, facilities costs, and other expenses related to day-to-day operations. We invited artists to apply for grants of up to \$5,000 to complete creative projects and opportunities for professional growth. In September, we convened review panels of arts administrators, artists, and community leaders from across the state to evaluate applications and make funding recommendations at a series of public meetings. Following their deliberations, we awarded \$338,300 to 24 organizations and \$98,526 to 21 artists* to support activities taking place between October 1, 2022 and September 30, 2023.

Arts & Economic Prosperity 6



The newly released Arts & Economic Prosperity 6 (AEP6) is an economic and social impact study of the nation's nonprofit arts and culture industry. Building on its 30-year legacy as the largest and most inclusive study of its kind, AEP6 provides detailed findings on 373 regions from across all 50 states and Puerto Rico—ranging in population from 4,000 to 4 million—and representing rural, suburban, and large urban communities. Culture Works partnered with Americans for the Arts to ensure that the Dayton Region (which for the purposes of this study is Montgomery, Clark, Greene, and Miami Counties) was included. With its largest cohort ever, AEP6 used a rigorous methodology to document the economic contributions of the arts and culture industry, demonstrating locally as well as nationally that nonprofit arts and culture are a critical economic driver of vibrant communities. The arts and culture industry supports jobs, generates government tax revenue, strengthens the visitor economy and community vibrancy, and helps to preserve authentic cultural experiences.

For the first time, AEP6 expanded beyond the economic and financial data to learn about the nonprofit arts and culture sector's social impact on the overall well-being of communities and the importance of affirming spaces in BIPOC (Black, Indigenous, People of Color) and ALAANA (African, Latine, Asian, Arab, Native American) identifying communities. By measuring the industry's wide-ranging impact, public and private sector leaders can work together to secure arts and culture funding and arts-friendly policies that shape more vibrant and equitable communities.

AEP6 provides compelling evidence that the nonprofit arts and culture sector is a significant industry in the Dayton Region—one that generated \$239.4 million in total economic activity during 2022. This spending—\$96.9 million by nonprofit arts and culture organizations and an additional \$142.5 million in event-related spending by their audiences—supports 4,490 jobs, generates \$153.6 million in household income for local residents, and delivers \$42.8 million in tax revenues to local, state, and federal governments. This study sends a strong signal that, even in the aftermath of the COVID-19 pandemic and the resulting recession, nonprofit arts and culture is a formidable industry. AEP6 demonstrates that when we support the arts, we are investing in the Dayton Region's economic and community well-being.

Arts + Wellness



Local organizations who participated in this outstanding program included United Rehabilitation Services, the Dayton Metro Library, Dayton Children's, Diabetes Dayton, Montgomery County, the Better Business Bureau, Generation Dayton, CareSource, and The Dayton Foundation. Premier Health was the largest participant in the program, with over 40 separate Arts + Wellness experiences scheduled for various Premier locations. Hundreds of Premier employees participated in activities such as sound bowls and meditation, line dancing, qigong, yoga, painting, and the enjoyment of flute and classical guitar on the care floors of the hospitals.

Arts + Wellness was an ongoing focus at Culture Works over the past year. Montgomery County continued their funding of this program by supporting the placement of artists who had learned arts and wellness skills during our 2022 workshop into local organizations to facilitate employee wellness and assist with recovery from the stresses of the COVID-19 pandemic through arts experiences and performances.

As a separate Premier Health project, Culture Works coordinated the work of local mosaic artist Jes McMillan of the Mosaic Institute to facilitate the commission of a 12' x 12' mosaic mural, which was divided into 11 sections. Employees at each Premier hospital and major office location took part in the creation of their own section of the mural by placing mosaic pieces onto the artwork over the course of a week. Many individual mosaic pieces included written employee messages as a path to healing and mental wellness. When placed together, the 11 sections form a circular design that aligns with the Premier Health program theme, "Arts & Wellness: Find Your Center."

We were so pleased to be able to bring arts and wellness experiences to employees feeling the stress of working in a pandemic-impacted environment while providing paid professional work to the local artist community—also severely impacted by the effect of COVID-19. We are grateful to Montgomery County for their generous support of the program.





Our Town Dayton Creative Placemaking Project

In September 2022, Culture Works introduced the Our Town Dayton Creative Placemaking Project. Funded by the National Endowment for the Arts' (NEA) Our Town grant program, Our Town Dayton is mobilizing local artists to create a communitydeveloped art installation at the Edgemont Solar Garden in West Dayton while also providing professional development training—"The Art of Business"-for participating artists. In fiscal vear 2022–2023, seven experienced local artists reviewed curriculum and planned entrepreneurial classes for 30 emerging artists, who represent the diversity of our region in their artistic disciplines, ages, ethnicities, professional experience and expertise, and artistic points of view.

In June 2023, we moved from the classroom to experiential training. At the Edgemont Solar Garden's summer festival, artists and Solar Garden leadership engaged the community in hands-on art, discussed the Our Town project objectives, and solicited opinions and ideas. Based on the community's input, the artists then worked together to develop plans for a creative, restorative space in the garden. On September 16, 2023, more than 200 community members, two Dayton City Commissioners, two Montgomery County Commissioners, and representatives of the Hunger Initiative, Central State, the Montgomery County Arts and Cultural District, and the Daughters of the American Revolution joined in a groundbreaking ceremony at the Edgemont Solar Garden's Harvest Festival.



Looking ahead to next year, Our Town Dayton is scheduled for completion in April of 2024, and the art installation will be dedicated at the Edgemont Solar Garden's Spring Planting Festival. In addition, Sinclair Community College has offered college business credit to any participating trainee artist that submits a portfolio of their classroom and hands-on experience for review at the close of the project.

Culture Works is grateful to CenterPoint Energy, the Montgomery County Arts and Cultural District, and Jasmine Brown of De'Lish for joining the NEA in support of this project by providing matching funding. Culture Works is thrilled to serve a community so willing to partner in growing the creative sector, and we believe that—in the same way that sun, rain, and care create beautiful produce in the Edgemont Solar Garden— these partnerships will produce a flowering of creativity in our community.
